## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

H. JELDNESS HALFWAY, OR 97834

confirms the right to use the waters of PINE CREEK for IRRIGATION of 175.5 ACRES, DOMESTIC and LIVESTOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 11, at Page 235. The date of priority is 1883 for Tract 1 and 1890 for Tract 2.

The points of diversion are located as follows:

FOOT HILLS DITCH FOR TRACT 1; AND POSEY VALLEY DITCH FOR TRACT 2

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, measured at the point of diversion and shall be further limited to a diversion of not to exceed ONE-ACRE FOOT PER ACRE DURING JULY, ONE ACRE FOOT PER ACRE DURING AUGUST, AND ONE-HALF ACRE FOOT PER ACRE DURING SEPTEMBER, for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
