CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PINE LAKES DITCH AND RESERVOIRS CO. HALFWAY, OR 97834

confirms the right to use the waters of UPPER TWIN LAKE, LOWER TWIN LAKE AND EAST LAKE, at head of EAST FORK of PINE CREEK for STORAGE AND SUPPLEMENTAL IRRIGATION of 1197.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 11, at Page 311. The date of priority is 1903.

The amount of stored water to which this right is entitled is limited to an amount actually beneficially used for said purposes, and is a portion of the amount originally evidenced by Certificate 27737. The portion allowed for this right, together with the portion allowed for the part of the original Certificate 27737 that was modified by T-11483, shall not exceed 175.0 acre-feet from Upper Twin Lake, 45.0 acre-feet from Lower Twin Lake and 90.0 acre-feet from East Lake at head of East Fork of Pine Creek.
