## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CURTIS F. AND ROBIN L. KADELL 26401 SW BALLSTON RD SHERIDAN OR 97378

confirms the right to use the waters of SOUTH YAMHILL RIVER, tributary to YAMHILL RIVER for IRRIGATION of 20 ACRES.

This right was perfected under Permit 36045. The date of priority is APRIL 28, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.25 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 25, 2004, at Special Order Volume 60, Page 373, approving Transfer Application 7228, and together with Certificate 80783, supersedes Certificate 42868, State record of Water Right Certificates.
