CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CIRCLE C IMPROVEMENT DISTRICT
 PO BOX 603
 TERREBONNE OR 97760

confirms the right to use the waters of FOUR WELLS in the DESCHUTES BASIN for DOMESTIC USE FOR 72 FAMILIES, and IRRIGATION: being 0.08 cubic feet per second for domestic use, and 0.81 cubic feet per second for irrigation; being an equal quantity from each well.

This right was perfected under Permit G-7872. The date of priority is DECEMBER 29, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.89 cubic feet per second measured at the wells.

The wells are located as follows:

If for irrigation, this appropriation shall be limited to 1/80th of one cubic per second of its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed three acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall be subject to such reasonable rotation as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all time

The water user shall install and maintain a weir, meter, or other suitable measuring device and keep a complete record of the amount of ground water withdrawn.
