CERTIFICATE OF WATER RIGHT

TUALATIN VINEYARDS INC. 10850 NW SEAVEY RD FOREST GROVE OR 97116

confirms the right to use the waters of A RESERVOIR CONSTRUCTED UNDER PERMIT R-1232, tributary to WEST DAIRY CREEK for SUPPLEMENTAL IRRIGATION of 39.8 ACRES.

This right was perfected under Permit S-20602. The date of priority is JULY 20, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.0 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet per acre for each acre irrigated in any one irrigation season and shall be further limited to a total of not to exceed 3.0 acre-feet in any one irrigation season.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain a totalizing flow meter or other suitable device for measuring and recording the quantity of water used.

This certificate is issued to confirm a CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 27, 2004, at Special Order Volume 62 Page 427, approving Transfer Application 8359, and together with Certificate 81073, supercedes Certificate 21970, State record of Water Right Certificates.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
