CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A RESERVOIR CONSTRUCTED UNDER PERMIT R-1232, tributary to WEST DAIRY CREEK for SUPPLEMENTAL IRRIGATION of 14.06 ACRES.

This right was perfected under Permit S-20602. The date of priority is JULY 20, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.03 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of the equivalent to 2.5 ACRE FEET per acre for each acre irrigated during the irrigation season of each year and shall be further limited to a total of not to exceed 1.03 ACRE FEET in any one irrigation season.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
