CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 2 AND WELL 3 in MCKAY CREEK BASIN for IRRIGATION of 14.05 ACRES.

This right was perfected under Permit G-9221. The date of priority is FEBUARY 5, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.18 CUBIC FOOT PER SECOND (CFS), BEING 0.06 CFS FROM WELL 2 AND 0.12 CFS FROM WELL 3, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of appropriation (wells), shall not exceed the quantity of water available from the original point of appropriation described as follows:

Water shall be acquired from the same aquifer (water source) as the original point of appropriation and shall be limited to groundwater production from no deeper than 530 feet below land surface.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CHANGE IN POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 19, 2007, at Special Order Volume 72, Page 376, approving Transfer Application 9969, and together with Certificate 83382, supersedes Certificate 61391, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
