 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the COLUMBIA RIVER, a tributary to the PACIFIC OCEAN for SUPPLEMENTAL IRRIGATION of 199.65 acres.

This right was perfected under Permit S-45108. The date of priority is MAY 23, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.874 CUBIC FEET PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the river.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-FORTIETH of one cfs, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
