 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SHERWOOD SCHOOL DISTRICT
 23295 SW MAIN ST
 SHERWOOD OR 97140

confirms the right to use the waters of A WELL in the CHICKEN CREEK BASIN for IRRIGATION of 4.02 ACRES.

This right was perfected under Permit G-11787. The date of priority is June 21, 1991. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.014 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

2 S	1 W	WM	30	NW SW	795 FEET SOUTH AND 1015 FEET EAST FROM THE NW CORNER OF THE NWSW OF SECTION 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 1.75 acre-feet per acre for each acre irrigated during the irrigation season of each year and an annual volume limitation not to exceed 7.03 acre feet.

The period of use is March 1 through October 31.

A description of the place of use is as follows:

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other suitable measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW
 This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- C. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times.

The Director may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water shall be limited when it interferes with any prior surface or ground water rights.

The use of water under this right was perfected under CW-60. For purposes of future transfers, it is not the intention to permanently layer this water right with any other right existing for the same lands. Therefore, this right is not subject to the layered water right restrictions contained in ORS 540.510(1). Upon transfer of title to the lands to which this right is appurtenant, this right shall be subject to ORS 537.490(3).

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 89, page 705, approving Conserved Water Application CW-60. This certificate together with certificate 88333 and certificate 89002, and CW-60, supersedes Certificate 85185, State Record of Water Right Certificates.
