 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACOB D. WOOD
 11161 TABLE ROCK RD
 CENTRAL POINT OR 97502

confirms the right to use the waters of ANNA CREEK, tributary to WOOD RIVER, for IRRIGATION of 10.0 ACRES.

This right was perfected under Permit S-8312. The date of priority is JUNE 25, 1927. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.13 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

33 S	7.5 E	WM	5	NE SW	SOUTH 12 DEGREES 23 MINUTES 20 SECONDS WEST, 2705 FEET FROM N1/4 CORNER, SECTION 5

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

33 S	7.5 E	WM	4	NE SW	9	10.0

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available from the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

When required by the Department, the water user shall install and maintain a headgate, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm A CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered FEBRUARY 4, 1994, at Special Order Volume 48, Page 108, approving Transfer Application 6138, and together with Certificate 68358, supercedes Certificate 7834, State Record of Water Right Certificates.
