

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 257.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 126.1 ACRES.

This right was perfected under Permit 50945. The dates of priority are MAY 8, 1987 FOR IRRIGATION OF 15.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.3 ACRES, JUNE 29, 1987 FOR SUPPLEMENTAL IRRIGATION OF 28.4 ACRES, FEBRUARY 3, 1988 FOR SUPPLEMENTAL IRRIGATION OF 30.4 ACRES, APRIL 12, 1988 FOR IRRIGATION OF 23.8 ACRES, APRIL 25, 1988 FOR IRRIGATION OF 66.7 ACRES, JULY 26, 1989 FOR IRRIGATION OF 69.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 33.0 ACRES, AND AUGUST 2, 1989 OF IRRIGATION OF 81.2 ACRES.

The use is limited to not more than 4.80 CUBIC FEET PER SECOND (CFS), BEING 0.62 CFS WITH A PRIORITY DATE OF MAY 8, 1987, 0.36 CFS WITH A PRIORITY DATE OF JUNE 29, 1987, 0.38 CFS WITH A PRIORITY DATE OF FEBRUARY 3, 1988, 0.30 CFS WITH A PRIORITY DATE OF APRIL 12, 1988, 0.83 CFS WITH A PRIORITY DATE OF APRIL 25, 1988, 1.29 CFS WITH A PRIORITY DATE OF JULY 26, 1989, AND 1.02 CFS WITH A PRIORITY DATE OF AUGUST 2, 1989, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

A description of the place of use to which this right is appurtenant is as follows:
