confirms the right to use the waters of MIDDLE FORK MALHEUR RIVER, tributary to MALHEUR RIVER for IRRIGATION of 215.6 ACRES AND DOMESTIC.

This right was perfected under Permit E-144. The date of priority is JUNE 17, 1912. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.7 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The water user shall divert the water to which the user is entitled under the subject right at either point of diversion for the Drewsey Reclamation Company Ditch or at the herein described alternate point of diversion, but not at both at the same time.

The amount of water diverted from Middle Fork Malheur River at the herein authorized alternate point of diversion shall not exceed the quantity available for the subject water right at the Drewsey Reclamation Company Ditch point of diversion from the Middle Fork Malheur River.

The amount of water diverted from the Middle Fork Malheur River at the herein described alternate point of diversion shall be subject to the operation and maintenance of an in line flow meter, or other suitable measuring device.

This certificate is issued to confirm AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered March 12, 1982, at Special Order Volume 36, Page 35, approving Transfer Application T-4647, and together with Certificate 89017, supercedes Certificate 49682, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
