CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 2, within the FORT ROCK BASIN for IRRIGATION of 129.2 ACRES.

This right was perfected under Permit G-9167. The date of priority is DECEMBER 16, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.6 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered MAY 18, 1998, at Special Order Volume 52, Page 513, approving Transfer Application 7556, and together with Certificate 75636, supercedes Certificate 54631, State record of Water Right Certificates.
