CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MT. VERNON IRRIGATION AND POWER CO.
MT. VERNON, OR 97865

confirms the right to use the waters of the JOHN DAY RIVER AND BEECH CREEK, tributary to the COLUMBIA RIVER, FOR IRRIGATION OF 441.47 ACRES AND DOMESTIC USE.

This right was perfected under Permit E-88. The date of priority is MARCH 6, 1911. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 5.614 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
