CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RALPH AND ANNE MORTER
PO BOX 21
IONE OR 97843

confirms the right to use the waters of WELL 1 and WELL 3, within the WILLOW CREEK BASIN, for IRRIGATION of 42.4 ACRES.

This right was perfected under Permit G-4722. The date of priority is SEPTEMBER 25, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.41 CUBIC FOOT PER SECOND, NOT TO EXCEED 127.2 ACRE FEET OF WATER ANNUALLY, or its equivalent in case of rotation, measured at the wells, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of these wells, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of these wells at the time of perfection of this right.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells of Oregon.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JULY 3, 2003, at Special Order Volume 57, Page 1190, approving Transfer Application 8586, and together with Certificate 79906, supercedes Certificate 79241, State record of Water Right Certificates.
