The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.21 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in CHARACTER OF USE AND PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 2, 2001, at Special Order Volume 55, Page 9, approving Transfer Application 8582, supercedes Certificate 45797, State record of Water Right Certificates.
