CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROCK CREEK DISTRICT IMPROVEMENT COMPANY PO BOX 28 WAMIC OR 97063

confirms the right to use the waters of ROCK CREEK, THREEMILE CREEK, NORTH FORK GATE CREEK, AND ROCK CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-780, tributaries of WHITE RIVER, for SUPPLEMENTAL IRRIGATION OF 11.0 ACRES and 3.0 ACRES-EQUIVALENT FOR POND MAINTENANCE.

This right was perfected under Permit S-15519. The date of priority is MARCH 13, 1939.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated UP TO JULY 1ST OF EACH YEAR AND THEREAFTER not to exceed ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated FROM DIRECT FLOW AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 1.0 ACRE FOOT PER ACRE DURING AND 30-DAY PERIOD UP TO JULY 1ST OF EACH YEAR AND NOT TO EXCEED 3.0 ACRE-FEET PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR FROM DIRECT FLOW AND STORAGE FROM ROCK CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-780.
