## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARREN AND VIVIAN TAYLOR 41095 TAYLOR LANE PENDLETON OR 97801

confirms the right to use the waters of BIRCH CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 65.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is OCTOBER 1902.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.81 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion, subject to the provisions of paragraph 33 of said decree and all other conditions and limitations of said decree.

The water user shall maintain a fish screen or fish by-pass device.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
