CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARREN AND VIVIAN TAYLOR

PENDLETON OR 97801

confirms the right to use the waters of UMATILLA RIVER, a tributary of the COLUMBIA RIVER, and BIRCH CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 12.5 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1892.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.15 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion, subject to the provisions of paragraph 33 of said decree and all other conditions and limitations of said decree.

The point of diversion is located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available from the original points of diversion.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device.


The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 17, 2003, at Special Order Volume 58, Page 439, approving Transfer Application 6588, together with Certificate 80490, supercedes Certificate 2619, State Record of Water Right Certificates.
