## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAY WILLIAMS T O WILLIAMS AND ASSOCIATES 49654 UMAPINE RD MILTON FREEWATER OR 97862

confirms the right to use the waters of PINE CREEK, tributary of COLUMBIA RIVER, for IRRIGATION of 137.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 148. The date of priority is 1874.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.0 ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD, NOR 3.0 ACRE FEET PER ACRE DURING THE IRRIGATION SEASON BEGINNING APRIL 1<sup>ST</sup> AND ENDING OCTOBER 1<sup>ST</sup> FROM PINE CREEK, or its equivalent in case of rotation, measured at the point of diversion.

The quantity of water diverted at the new point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available from the original points of diversion.

If water for these rights is available at the original points of diversion on Pine Creek, existing water rights on Pine Creek above the confluence of Dry Creek will not be regulated for these rights.

If there is insufficient water in Pine Creek to satisfy existing water rights diverting water between the original points of diversion and the additional point of diversion, the additional point of diversion may be regulated to satisfy the existing rights.

When required by the Department, the water user or irrigation district shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

When required by the Department, the water user or irrigation district shall operate and maintain the headgate and measuring device, as needed. The water user or irrigation district shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor the accuracy of the measuring device, as needed.

Water shall be acquired from the same surface water source as the original points of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 24, 1998, at Special Order Volume 52, Page 576, approving Transfer Application 7834, supercedes Certificate 46240, State Record of Water Right Certificates.
