The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.22 CUBIC FOOT PER SECOND AND SHALL NOT EXCEED 49.75 ACRE-FEET PER YEAR, or its equivalent in case of rotation, measured at the point of diversion.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. Specifically, the water user shall measure and keep a daily running log of the volume of water used for dust abatement and the estimated volumetric water content of rock exported from the site. This record shall be available to the Watermaster whenever needed for determining water quantities.

The original points of diversion of surface water shall not be retained as an additional or supplemental point of diversion. The original points of diversion are described as follows:
