CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS, within the FORT ROCK BASIN for IRRIGATION of 257.3 ACRES.

This right was perfected under Permit G-9202. The date of priority is JANUARY 26, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.22 CUBIC FEET PER SECOND (CFS), being 1.57 CFS from Well 1 for irrigation 125.4 acres and 1.65 CFS from Well 2 for irrigation of 131.9 acres or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
