CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL (MARI 63578), tributary to WILLAMETTE RIVER (COLUMBIA RIVER) for IRRIGATION of 68.8 ACRES.

This right was perfected under permit G-2902. The date of priority is MAY 13, 1965. The amount of water to which this right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.86 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of appropriation.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the additional point of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation which is located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described.

This certificate is issued to confirm a change in an ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered APRIL 15, 2011, at Special Order Volume 83, Page 1008, approving Transfer Application T-11142, and, supersedes Certificate 34687, State Record of Water Right Certificates.
