CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANNA AND NEAL J DOW FLP
28000 SE PAULINA HWY
PRINEVILLE OR 97754

confirms the right to use the waters of HORSE HEAVEN CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-1130, tributary to the CROOKED RIVER for IRRIGATION of 42.1 ACRES.

This right was perfected under permit S-20200. The date of priority is MARCH 2, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD'S) are located as follows:

POD 1 – Reservoir Dam	16 S	19 E	WM	16	NW NE	450 FEET SOUTH AND 3660 FEET EAST FROM NW CORNER, SECTION 16
POD 2	16 S	19 E	WM	17	SE NE	2340 FEET SOUTH AND 230 FEET WEST FROM NE CORNER, SECTION 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 4.0 ACRE FEET PER ACRE for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1130.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the above POD'S shall not exceed the quantity of water available at the original POD's being:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The former place of use of the transferred right shall no longer receive water under this right.


The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.

When required by the Department, the water user shall install, maintain and operate headgates to control and regulate the quantity of water diverted. The types and plans of the headgates must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described and is subject to all conditions and limitations contained in certificate 86198.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered January 11, 2011, at Special Order Volume 83, Page 363, approving Transfer Application T-11123, and together with Certificate 86789, supersedes Certificate 86198, State Record of Water Right Certificates.
