CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of HORSE HEAVEN CREEK, tributary to CROOKED RIVER for IRRIGATION of 4.8 ACRES.

This right was perfected under permit E-235. The date of priority is JANUARY 18, 1915. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the original point of diversion, being:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The former place of use of the transferred right shall no longer receive water under this right.

The water user shall maintain and operate the existing measurement devices and shall make improvements as may be required by the Department.

When required by the Department, the water user shall install, maintain and operate headgates to control and regulate the quantity of water diverted. The types and plans of the headgates must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described and subject to all conditions and limitations contained in certificate 86201.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 11, 2011, at Special Order Volume 83, Page 363, approving Transfer Application T-11123, and together with Certificate 86791, supersedes Certificate 86201, State Record of Water Right Certificates.
