confirms the right to use the waters of JACK CREEK AND LONG PRAIRIE CREEK, tributaries of WILLIAMSON RIVER, for IRRIGATION of 905.8 ACRES.

This right was perfected under Permit S-42725. The date of priority is MARCH 25, 1977 FOR 12.17 CUBIC FEET PER SECOND (CFS) AND JANUARY 13, 1978 FOR 10.48 CFS. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 22.65 CFS, BEING 10.62 CFS FROM JACK CREEK FOR IRRIGATION OF 424.8 ACRES AND 12.03 CFS FROM LONG PRAIRIE CREEK FOR IRRIGATION OF 481.0 ACRES, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
