CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAIBEL RANCHES LLC

confirms the right to use the waters of MOWRY CREEK (MAURY CREEK), a tributary to the CROOKED RIVER for IRRIGATION of 31.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1885.

The period of use is February 1 through December 1.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.39 CUBIC FOOT PER SECOND, and a reasonable amount for domestic and stock measured at the point of diversion from the source.

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
17 S	21 E	WM	10	NE SW	30 FEET SOUTH AND 1450 FEET EAST FROM THE WEST 1/4 CORNER, SECTION 10

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The former place of use shall no longer be irrigated as a part of these water rights.


**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 8, 2002, at Special Order Volume 56, Page 9, approving Transfer Application T-7341, and supersedes Certificate 534, State Record of Water Right Certificates.
