CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAIBEL RANCHES LLC
8055 SW POWELL BUTTE HWY
POWELL BUTTE OR 97753

confirms the right to use the waters of MAURY CREEK , tributary to CROOKED RIVER, and MAINLINE RESERVOIR 1, CONSTRUCTED UNDER PERMIT R-4871, for IRRIGATION of 68.5 ACRES.

This right was perfected under Permit 32025. The date of priority is SEPTEMBER 26, 1966, FOR STORAGE AND NOVEMBER 2, 1966 FOR MAURY CREEK. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.71 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-4871.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:


The former place of use shall no longer be irrigated as a part of these water rights.

The water user shall maintain and operate fish screening as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

The right to the use of the water for the purpose aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 8, 2002, at Special Order Volume 56, Page 9, approving Transfer Application T-7341, and supersedes Certificate 52349, State record of Water Right Certificates.
