## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DURGAN RANCH LLC 10809 SE DURGAN RANCH RD PAULINA OR 97751

confirms the right to use the waters of WOLF CREEK, tributary to BEAVER CREEK, tributary to the CROOKED RIVER for IRRIGATION of 194.5 ACRES and LIVESTOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The priority dates are 1878 for irrigation of 150.0 acres and 1898 for the irrigation of 44.5 acres. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.44 CUBIC FEET PER SECOND, measured at the points of diversion.

The period of use is February 1 to December 1 of each year.

The points of diversion are located as follows:

The amount of water to which such right is entitled and is hereby confirmed for purposes aforesaid is limited to an amount beneficially used for said purposes, and shall not exceed a reasonable amount used for LIVESTOCK, and shall not exceed FOUR acre-feet per acre for each acre irrigated each year, and shall not exceed ONE acre-foot per acre in any 30 days.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in Certificate 623 and any other related decree.

When required by the Department, the water user shall install and maintain headgate, in-line flow meter, weis, or other suitable device for measuring and recording the quantity of water diverted. The types and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered October 1, 2005, at Special Order Volume 67, Page 235, approving Transfer Application T-9124 and supersedes Certificate 623, State Record of Water Right Certificates.
