CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAYMOND S. AND JEAN BELNAP
4137 KOCHSMEIER RD
VALE OR 97918

confirms the right to use the waters of WELL #2, WELL #5 and WELL #8 within the COW CREEK BASIN for IRRIGATION of 194.1 ACRES being 2.2 ACRES from WELL #2, and 191.9 ACRES from WELLS #5 & #8.

This right was perfected under Permit U-359. The date of priority is SEPTEMBER 20, 1950. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.40 CUBIC FEET PER SECOND (cfs), being 0.01 cfs from WELL #2, and 2.39 cfs from WELLS #5 & #8, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of appropriation (WELL #2 & WELL #8), together with the quantity of diverted at the original point of appropriation (WELL #5), shall not exceed the quantity of water available from the original point of appropriation.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to the use of the water for the purposes aforesaid is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND TO ADD TWO ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered February 17, 2005, at Special Order Volume 63, Page 311, approving Transfer Application T- 8787, and supersedes Certificate 80440, State Record of Water Right Certificates.
