confirms the right to store the waters of BASKETT SLOUGH, tributary of RICKREALL CREEK, in Morgan Reservoir, appropriated under Application No. 38036, Permit No. 28252, for MULTIPURPOSE, INCLUDING, BUT NOT LIMITED TO, WETLAND ENHANCEMENT AND WILDLIFE USE.

This right was perfected under Permit R-3093. The date of priority is SEPTEMBER 6, 1962. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 210.0 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.
