CERTIFICATE OF WATER RIGHT

confirms the right to store the waters of BASKETT SLOUGH, tributary of RICKREALL CREEK, in Morgan Brothers Reservoir, appropriated under Application number 40481, Permit number 30166, for MULTIPURPOSE, INCLUDING, BUT NOT LIMITED TO, WETLAND ENHANCEMENT.

This right was perfected under Permit R-4520. Enlargement of reservoir constructed under Permit R-3093. The date of priority is DECEMBER 15, 1964. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 275.0 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered JUNE 15, 1999, at Special Order Volume 53, Page 859, approving Transfer Application 7183, supercedes Certificate 37463, State record of Water Right Certificates.
