CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHILIP R. OLSON
23725 SE OLD BETHEL RD
AMITY OR 97101

confirms the right to use the waters of ASH SWALE AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6154, tributaries of SALT CREEK, for IRRIGATION OF 26.3 ACRES.

This right was perfected under Permit S-38064. The date of priority is JULY 19, 1974. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.31 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

5 S	4 W	WM	33	SE NW	47	2720 FEET NORTH AND 1570 FEET EAST FROM SW CORNER, SECTION 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-6154.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

6 S	4 W	WM	4	NE NW	40	14.6
6 S	4 W	WM	4	NW NW	40	8.5

The water user shall maintain an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 20, 2009, at Special Order Volume 77, Page 279, approving Transfer Application 10450, and together with Certificate 85293, supercedes Certificate 51799, State record of Water Right Certificates.
