## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVE RICKMAN 69705 OLD EXPERIMENT RD BURNS OR 97720

confirms the right to use the waters of POISON CREEK AND FOLEY SLOUGH, tributaries of SILVIES RIVER for IRRIGATION of 174.3 ACRES.

Note: The Foley Slough is a distributary of the Silvies River that divides from the Silvies in the NE NE, Section 26, T22S, R30E, W.M. Water diverted down the Foley Slough Branch enhances the flow in Poison Creek that can be diverted from the Poison Creek diversions.

This right was confirmed by the Silvies River Decree of the Circuit Court of the State of Oregon for Harney County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 147. The date of priority is 1894.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.18 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
