CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of the COLUMBIA RIVER, tributary to the PACIFIC OCEAN, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was perfected under Permit S-36940. The date of priority is JUNE 29, 1973, plus one minute. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.14 CFS, or its equivalent in case of rotation, measured at the point of diversion, from March 1 October 31.

The description of the stream reach in which flows are to be maintained is as follows:

From the location of the diversion authorized previously under Certificate 87894, located approximately at RM 269:

4 N	25 E	WM	2	NE NW	7	120 FEET SOUTH AND 2980 FEET WEST FROM THE NE CORNER OF SECTION 2

to the mouth of the Columbia River at River Mile 0.0.

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original point of diversion.


Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470 unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 87894, and any related decree.

This certificate is issued to correct a scrivener's error in the quantity of water, supersedes Certificate 88816, and confirms an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 89, Page 451, approving Conserved Water Application CW-68. This Certificate together with Certificate 88117 and the conserved water under CW-68, supersedes Certificate 87894, State Record of Water Right Certificates.
