## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLIE W. REED ROUTE 1, BOX 202 MCMINNVILLE, OR

confirms the right to use the waters of the SOUTH YAMHILL RIVER, a tributary to the YAMHILL RIVER for IRRIGATION of 25.8 ACRES.

This right was perfected under Permit S-19336. The date of priority is SEPTEMBER 14, 1949. The amount of water to which this right is entitled and herby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
