CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH SANTIAM RIVER, tributary to SANTIAM RIVER, for IRRIGATION of 114.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Marion County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 462. The date of priority is 1870.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.01 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 4, 1997, at Special Order Volume 51, Page 1052, approving Transfer Application 7583, and together with Certificate 75135, supercedes Certificate 53769, State Record of Water Right Certificates.
