CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

G. W. HALES O'BRIEN, OR 97534

confirms the right to use the waters of EAST FORK ILLINOIS RIVER for the purpose of IRRIGATION, DOMESTIC, and STOCK for TRACT #1; MINING for TRACT #2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13. The date of priority is 1853.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE CUBIC FOOT PER SECOND FOR EACH 50 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON FROM APRIL 1 TO NOVEMBER 1 OF EACH YEAR FOR TRACT #1; 32.04 CUBIC FEET PER SECOND FOR TRACT #2.
