CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of EAST FORK ILLINOIS RIVER for the purpose of MINING.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13, at Page 70. The date of is 1895.

The amount of water to which this right is entitled is limited to an amount actually beneficially used for said purposes, and shall not exceed 72.27 CUBIC FEET PER SECOND.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
