## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KIRPAL LIGHT SATSANG INC. PO BOX 10 UMPQUA OR 97486

confirms the right to use the waters of UNNAMED STREAM, SURFACE RUN-OFF, RESERVOIRS A, B, C, D, AND E (CONSTRUCTED UNDER PERMIT R-11367), tributaries to the UMPQUA RIVER, for DOMESTIC USE FOR TWO FAMILIES, AND FOR IRRIGATION OF 36.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.5 ACRES.

This right was perfected under Permit S-51211. The date of priority is JUNE 14, 1990. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.979 CUBIC FOOT PER SECOND (CFS), BEING 0.089 CFS FOR DOMESTIC USE FOR TWO FAMILIES AND 0.89 CFS FOR IRRIGATION OF 36.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.5 ACRES, or its equivalent in case of rotation, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water available from the original points of diversion located as follows: RESERVOIR A, B, C, D, E, and the UNNAMED STREAM.

Water use measurement conditions:

- A. The water user shall maintain the meters or other suitable measuring devices in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered July 9, 2012, at Special Order Volume 88, Page 50, approving Transfer Application T-9447, and together with Certificate 87664, supersedes Certificate 87402, State Record of Water Right Certificates.
