confirms the right to use the waters of A WELL, within the FORT ROCK VALLEY BASIN for IRRIGATION of 9.5 ACRES.

This right was perfected under Permit G-10701. The date of priority is NOVEMBER 3, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.119 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The quantity of water diverted at the additional point of appropriation (well), shall not exceed the quantity of water lawfully available from the original point of appropriation described as follows:

The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
