CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT NIGHTENGALE
PRINEVILLE OR 97754

confirms the right to use the waters of CROOKED RIVER, tributary to DESCHUTES RIVER for IRRIGATION of 404.0 ACRES, LIVESTOCK AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1900.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a reasonable amount for stock and domestic use, and 5.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The period of allowed use for irrigation is February 1 until December 1 of each year.

The point of diversion is located as follows:



The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This certificate is issued to correctly describe the period of allowed use under the right consistent with the "Correction Certificate of Water Right" located adjacent to Certificate 845, State Record of Water Right Certificates, and supersedes certificate 52015.
