## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL No. 3, tributary of POISON CREEK SLOUGH for IRRIGATION OF 70.55 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.40 acres.

This right was perfected under Permit G-297. The date of priority is APRIL 20, 1956. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.995 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.
