CERTIFICATE OF WATER RIGHT

CHUCK EDER FARMS 11580 HOOK RD NE MT ANGEL OR 97362

confirms the right to use the waters of PUDDING RIVER, tributary to MOLALLA RIVER, for IRRIGATION of 64.0 ACRES.

This right was perfected under Permit S-17548. The date of priority is FEBRUARY 14, 1947. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.80 CUBIC FOOT PER SECOND (CFS), FURTHER LIMITED TO 0.80 CFS FROM ORIGINAL DIVERSIONS AND 0.33 CFS FROM WELL (ADDITIONAL POINT OF DIVERSION), IN ANY COMBINATION, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of diversion (well), together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available from the original points of diversion.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original points of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in ADDITIONAL POINT OF DIVERSION (WELL) approved by an order of the Water Resources Director entered MARCH 25, 1998, at Special Order Volume 52, Page 231, approving Transfer Application 7830, supersedes Certificate 22459, State record of Water Right Certificates.
