CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHUCK EDER FARMS 11580 HOOK RD NE MT ANGEL OR 97362

confirms the right to use the waters of ABIQUA CREEK, a tributary to PUDDING RIVER, for IRRIGATION of 28.0 ACRES.

This right was perfected under Permit S-15334. The date of priority is JULY 16, 1942. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.35 CUBIC FOOT PER SECOND (CFS) FROM RIVER AND 0.33 CFS FROM WELL, IN ANY COMBINATION, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This water right shall be regulated with other rights to the use of water from Abiqua Creek.

This certificate is issued to confirm a change in POINT OF DIVERSION (WELL) approved by an order of the Water Resources Director entered MARCH 25, 1998, at Special Order Volume 52, Page 231, approving Transfer Application 7830, and supersedes the right perfected under Special Order Volume 49, Page 271, Transfer Application 6599, and together with Certificate 87532, supersedes Certificate 16873, State record of Water Right Certificates.
