confirms the right to use the waters of GRANDE RONDE RIVER, a tributary of SNAKE RIVER for the purpose of IRRIGATION of 86.9 ACRES.

This right was perfected under Permit S-21885. The date of priority is NOVEMBER 13, 1952. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.09 CUBIC FEET PER SECOND (cfs), being 0.42 cfs from additional point of diversion (POD) #1 and 0.67 cfs from additional POD #2, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or other suitable measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate the fish screens and/or by-pass devices, as appropriate, at the points of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described.

This certificate is issued to confirm TWO ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered November 29, 2010, at Special Order Volume 83, Page 119, approving Transfer Application T-10861, and together with Certificate 86722, supersedes Certificate 27921, State Record of Water Right Certificates.
