confirms the right to use the waters of A WELL (LAKE 50650), a tributary of FORT ROCK BASIN for the purpose of IRRIGATION of 129.6 ACRES.

This right was perfected under Permit G-9233. The date of priority is February 23, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.33 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIAITON approved by an order of the Water Resources Director entered July 15, 1998, at Special Order Volume 52, Page 675, approving Transfer Application T-8005, and together with Certificate 75740, supersedes Certificate 53455, State Record of Water Right Certificates.
