CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CAMERON CLIFF
LA PINE, OR 97739

confirms the right to use the waters of CLIFF WELL a tributary of BRIDGE CREEK for the purpose of IRRIGATION of 312.6 ACRES.

This right was perfected under Permit G-5544. The date of priority is MARCH 28, 1972. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.91 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.



This certificate is issued to correct a scrivener's error in the quarter-quarter location of the point of appropriation described on Certificate 46780. This Certificate supersedes Certificate 46780, and describes the portion of the water right confirmed by Certificate 46780, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 22 2014, approving Transfer Application T-11629.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
