CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SILVER LAKE IRRIGATION DISTRICT
C/O LAWRENCE IVERSON
SILVER LAKE, OR 97638

confirms the right to use the waters of EAST THOMPSON VALLEY RESERVOIR enlarged under Permit R-4461, a tributary SILVER LAKE (DRY) for SUPPLEMENTAL IRRIGATION of 2493.1 ACRES.

This right was perfected under Permit S-29955. The date of priority is AUGUST 24, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1906.19 ACRE-FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate corrects a scrivener's error in the certificate recorded at page 81659, State Record of Water Right Certificates. Certificate 81659 incorrectly labeled the acreage as being primary and supplemental. Water right Certificate 81659 is for supplemental irrigation only.

This certificate describes that portion of the water right confirmed by Certificate 81659, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 22 2014, approving Transfer Application T-11629.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
