CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MIDDLE FORK IRRIGATION DISTRICT  
P.O. BOX 291  
PARKDALE, OREGON 97041

confirms the right to store the waters of CLEAR BRANCH in CLEAR BRANCH RESERVOIR (LAURANCE LAKE), tributary to MIDDLE FORK HOOD RIVER for SUPPLEMENTAL IRRIGATION AND FISH CULTURE.

This right was constructed under the terms of Permit R-4862.

The date of priority is APRIL 6, 1967.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3550 ACRE FEET (AF) being 2650 AF for SUPPLEMENTAL IRRIGATION, 150 AF FOR FISH CULTURE AND 750 AF FOR JOINT USE OF FISH CULTURE AND SUPPLEMENTAL IRRIGATION SUBJECT TO THE TERMS AND CONDITIONS OF AN ORDER OF THE STATE ENGINEER ENTERED MARCH 22, 1962.

The point of diversion is located:

CLEAR CREEK: 760 FEET SOUTH and 2590 FEET WEST from the NW CORNER, SECTION 27, being within the NE  $\frac{1}{4}$  NW  $\frac{1}{4}$  of SECTION 27, TOWNSHIP 1 SOUTH, RANGE 9 EAST, W.M.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.



The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights including prior rights for maintaining instream flows.

This certificate is issued to correctly allow storage for uses authorized under other water rights specifying the Clear Branch reservoir as a source, including Permit S-27788 authorized in 1962. This certificate supersedes Water Right Certificate numbered 87641.
